

DESKTOP LATINOTYPE END USER LICENSE AGREEMENT

This Desktop End User License Agreement (hereinafter, “EULA”, “License”, “Agreement” or “License Agreement”) is a legal agreement between you and Sociedad de Diseño Vergara, Hernández y Hernández Latinotype Ltda d/b/a LATINOTYPE (Tax RUT 76.174.455-0) for the use of the Font Software associated with this License Agreement. By downloading the Font Software or installing, copying, accessing, or otherwise using the Font Software, you agree to be bound by this Agreement. If you do not agree to the terms of this Agreement, do not download, install or use the Font Software.

1. Definitions.

The “**Font Software**” is digital software that generates typeface and/or the designs embodied therein when used with computers and other software (hereinafter “Font Software” or “Font[s]”).

“**Licensed Party**” is defined as an individual or company (*including its Representatives or Affiliates, understanding by these “any person, corporation, partnership, trust, or other entity, existing or which has yet to exist, that, directly or indirectly, legally or beneficially, owns, is/will be owned by, or is/will be under common ownership with the subject entity or the subject entity’s ultimate parent. For purposes of the foregoing, “own”, “owned”, or “ownership” means holding ownership of, or the right to vote, fifty percent (50%) or more of the voting stock or ownership interest entitled to elect a board of directors or a comparable managing authority.*) purchasing this License (hereinafter “Licensed Party” or “you”).

“Typeface” means the typeface in all formats and forms, including but not limited to OpenType, TrueType, PostScript, WOFF, @font-face, webfont formats, variable fonts, hinting data, glyph outlines, metrics, kerning data, feature code, and any accompanying files, updates, or documentation.

“Latinotype” means Latinotype Ltda., the intellectual property holders and licensors of the Typeface Font Software, and all Latinotype font catalogue.

“Non-commercial” use is a use for solely personal purposes.

“Activity” means the unauthorised use, reproduction, copying, distribution, sublicensing, display, modification, adaptation, and/or creation of derivative works based upon the Recoleta Typeface Font Software, in whole or in part, including any font files, glyphs, outlines, designs, or related software components, as further described in this letter.

“Derivative Works” means any works, materials, or output that is based upon, derived from, incorporates, reproduces, publishes, or is created using the Typeface/Font Software, in whole or in part, whether directly or indirectly, including but not limited to any modification, reworking, translation, transformation, amendment, interpolation, exportation, conversion, extraction, reconstruction, or re-arrangement of the Font Software or any portion thereof. This includes, without limitation, any modification, manipulation, reuse, or alteration of glyphs, glyph shapes, outlines, vector data, Bézier curves, control points, nodes, spacing, kerning, proportions, Unicode assignments, character encoding, glyph mapping, OpenType or TrueType tables, feature code, hinting data, or any other source file, font data, or technical, structural, or visual characteristics of the Typeface/Font Software, whether embodied in software, vector artwork, static images, or

any other format. For the avoidance of doubt, a work shall constitute a Derivative Work irrespective of the extent of modification, and regardless of whether such work is recognisable as having been derived from the original Typeface/Font Software, provided that it is wholly or partly derived from, based upon, or created using the Typeface/Font Software or any underlying data or design elements thereof.

“**Webfont**” means web font formats and CSS technologies used to embed and display the Font Software on websites, including the Web Open Font Format (WOFF and WOFF2) and the CSS @font-face rule, which together enable the loading, rendering, and use of the Typeface within web pages or web-based applications.

“**Vector Data**” means any geometric or mathematical representation of Glyphs or characters, including outlines, Bézier curves, control points, nodes, paths, and any other structural or graphical data derived from or corresponding to the Typeface/Font Software.

“**Publishing**” means making any work or material available to the public, or any section of the public, whether directly or indirectly, by any means and in any format, including but not limited to print, digital, broadcast, online, or physical media. This includes, without limitation, the distribution, display, communication, transmission, or dissemination of any content incorporating the Typeface/Font Software, including within websites, mobile applications, software, social media platforms, advertising, marketing materials, packaging, products, or other commercial or non-commercial media. This further includes the making available of content in any rasterised or vectorised form, including but not limited to JPEG, PNG, SVG, PDF, or other image or graphic

file formats, as well as any exported, flattened, or converted outputs from design software or other tools. For the avoidance of doubt, Publishing includes the embedding, streaming, hosting, or serving of the Typeface/Font Software or any Derivative Works thereof to end users via any network or digital platform, regardless of whether the underlying font software is directly accessible.

“**Licensed User**” means any individual or entity that has obtained a valid, current, and fully paid licence to use the Font Software in accordance with the applicable licence agreement.

“**Unauthorised User**” means any use of the Font Software that is not expressly permitted under a valid licence, including but not limited to use exceeding the scope, territory, media, or number of users/devices permitted.

“**Embedding**” means the inclusion, incorporation, or linking of the Font Software within any digital product or environment, including but not limited to publishing, websites, mobile applications, software, e-books, PDFs, or other electronic documents, whether via @font-face, app bundling, or other methods.

“**Publishing**” means the inclusion, incorporation, or linking of the Font Software within any digital product or environment, including but not limited to publishing, websites, mobile applications, software, e-books, PDFs, or other electronic documents, whether via @font-face, app bundling, or other methods.

“**Brand Font**” means any use of the Font Software or Typeface as a primary or defining element of a company’s or organisation’s visual identity, including but not limited to use in logos, wordmarks, corporate identity systems, brand

guidelines, and other core brand communications across digital, print, packaging, advertising, or environmental applications, where the Typeface functions as a key identifier of the brand rather than incidental or supplementary text use.

“Distribution” means making the Font Software available to any third party by any means, including but not limited to sale, transfer, sharing, sublicensing, uploading, or making available for download, whether for commercial or non-commercial purposes.

“Third-Party” means any individual or entity other than the Licensed User, including but not limited to affiliates, contractors, agencies, manufacturers, printers, or clients.

“Commercial Use” means any use of the Font Software in connection with revenue-generating activity, brand promotion, advertising, product packaging, or any business-related purpose, direct or indirect.

“Apps” means any software, platform, system, service, or technology (whether web-based, desktop, mobile, embedded, or cloud-based), including without limitation any artificial intelligence, machine learning, generative, or automated systems, that processes, stores, renders, analyses, or otherwise uses the Font Software or Typeface in any form.

“Artificial Intelligence” (or “AI”) means any software, system, model, or technology, whether standalone or integrated into an application, that is capable of performing tasks typically requiring human intelligence, including without limitation learning from data, recognising patterns, generating outputs (such as text, images, audio, or designs), making predictions or

decisions, or producing derived or synthetic content through machine learning, neural networks, or other algorithmic processes.

“**Machine Learning**” (ML) means a subset of Artificial Intelligence involving algorithms, models, or systems that are designed to learn from data, identify patterns, and improve performance or generate outputs over time without being explicitly programmed for each task, including through training, fine-tuning, or automated adjustment of model parameters.

“**Infringing Materials**” means any materials, products, or content that incorporate or make use of the Font Software without proper authorisation, including all instances of Activity as defined above.

“**Effective Date**” means the date of this letter, from which all obligations, demands, and timelines stated herein shall apply.

2. Grant of License. Upon payment in full Latinotype grants to **Licensed Party** a non-exclusive, temporal, for non-commercial use, license to use the Font Software (described in Appendix A) together with any accompanying documentation, each in accordance with the terms and conditions of this Agreement, invoices and prior quotes agreed upon by the parties. It is hereby stated that, for all payment purposes, each party shall be individually responsible for ensuring compliance with all applicable tax laws for any payment received under this Agreement.

Desktop License. If you purchase a basic License, this License allows the Licensed User to use and install the Font Software by not more than two (2) Desktop computers at any one time.

Multi-User License. If you purchase a License for use of the Font Software by more than two (2) users, you may install the Font Software on the number of computers identified in the Order Receipt each of which must be owned by the Licensed Party.

Portable Computers. Use of the Font Software on a portable computer is permitted provided that the portable computer is owned by the Licensed Party and is not used to permit use of the Font Software by more than the number of users authorized under this Agreement.

Quantity Limitations on End Products for Commercial Use: You are permitted to use the Font Software within End Products for sale provided that the number of units does not exceed 10,000. If the required quantity is greater than 10,000 units, you must contact Latinotype directly by email at info@latinotype.com.

You are permitted to embed the Font Software in Adobe® Acrobat® (PDF) documents, solely for the purposes of presenting information and designs to others or for sending designs to a service bureau or printer for output or other preparation for production. You hereby agree that any PDF shall be made in a secure manner that allows only viewing and printing of the PDF, and not the editing or alteration of the content. Font Software shall be SUBSET when embedded and the PDF document shall be set as NON-EDITABLE. If you are not sure how to subset and/or create non-editable PDFs, consult the manual or publisher of the software application from which you are exporting PDFs. You are not permitted to embed the entire character set or substantially all of the character set comprising any Font that is subject to this License. Use of Font Software in PDF documents for sale or products utilizing other

forms of embedding of the Font Software for sale (for example as part of a commercial product such as a design template or an electronic book or use with a mobile device) is prohibited, and requires the purchase of a special license.

If at any time your use of the Font Software exceeds that permitted in the applicable License, you agree to immediately notify Latinotype and purchase the appropriate license.

Other relevant aspects:

- a. The Licensed Party shall only use the Font for_____.
- b. The use of the font software described above is granted exclusively to the Licensee. Therefore, no one other than the Licensee may use the font without first obtaining the corresponding license from Latinotype.
- c. The Services are provided on a non-exclusive basis, and the parties agree that Latinotype may market and offer its products and services (including, but not limited to, services of the same or similar nature to the Services provided under this Agreement) and conduct business with and for any third party, regardless of whether its business or that of such third party is, now or in the future, directly or indirectly competitive with that of the Licensee.
- d. Restrictions the use of the font software in any of the following circumstances and/or applications is not permitted without first obtaining the appropriate special licensing from latinotype:
 - i. alphabet or letterform-related products for resale or letterform-creation products or devices or on products for sale;

- ii. embedding in software and/or in electronic devices, electronic books, and for all gaming uses and/or devices;
- iii. storing, caching, serving or otherwise providing access to the font software to third parties via the internet for use or display on the internet, irrespective of the format or technology used;
- iv. use in film and/or use in television or broadcast via cable television or on the internet as webfonts; and installation of the fonts on a server for serving fonts to users
- v. use of the font software as a primary or core branding asset of any company, organisation, or commercial entity (including but not limited to logo design, wordmarks, core visual identity systems, corporate typography, or brand identity systems across digital, print, packaging, environmental, or advertising applications), where such entity generates or exceeds usd \$1,000,000 (or local currency equivalent) in annual revenue, requires a prior written special brand font license from latinotype.
- vi. artificial intelligence (ai), machine learning (ml), and automated systems (see; section 6).

If you wish to use the font software in a manner that is restricted under this license, contact latinotype for information about special licensing. For the avoidance of doubt, latinotype personnel performing services for the licensed party under this agreement may perform similar services for others during or after the term of this agreement.

Use by Third Parties. If you are a design consultancy, advertising agency, or purchasing this License for use by your client, you need to also purchase a license appropriate for your client's needs. Specifically, if your client will need copies of the Font Software and use copies of the Font Software, separate from your own uses, your client must also purchase a license for their own uses.

3. Internet Use. You are permitted to use the Font Software to make GIF, JPEG, and PNG pixel-based images for use on the Internet as part of a website design provided that the image creation is not automated or animated and the images are made personally by a Licensed User and not generated by a server, and that no embedding or other transmission of the Font Software is made possible. Embedding the Font Software in Web pages is expressly prohibited. You are not permitted to use the Font Software regarding embedded font objects or by any other means that embed the Font Software for the purposes of displaying the Fonts on the Internet or on wireless Web browsers.

4. Strictly No Artificial Intelligence (AI) and Machine Learning (ML) Use Important Restrictions:

1. You are strictly prohibited from using any Latinotype "Font Software" and/or "Typefaces" in any and all AI/ML "Artificial Intelligence" and/or "Machine Learning" , Text and/or Data Mining/Ai training without express permission. You are not authorised to use versions of the Font Software for;
 - a. machine learning,

- b. data-set creation,
- c. automated extraction,
- d. use beyond the scope of this End User License Agreement.

No content may be used to train machine learning systems unless expressly authorised. This includes, without limitation, any analysis, ingestion, processing, transformation, or extraction of the Font Software or its glyph data for the purpose of machine learning, dataset creation, or model training, whether direct or indirect. Any such use shall constitute a material breach of this Agreement and may result in immediate termination of this licence without notice.

2. Permitted Webfont Use: You may not:

- a. extract,
- b. decompile,
- c. convert the font software,
- d. make the font downloadable as a file,
- e. embed the font in applications where the font can be accessed outside the licensed environment,
- f. use the font to create derivative datasets of training material,
- g. use the font to create derivative artwork, graphics, designs, logos, or marketing material, including but not limited to;
 - i. "Artificial Intelligence",
 - ii. "Machine Learning",
 - iii. "Apps".

3. Limited WOFF Web Embedding Exception: You are permitted to embed the Webfont (“WOFF”) in a website using WOFF./WOFF2 formats only, solely for the purpose of displaying text on webpages, this strictly does not include the use of “AI” or “ML”.

5. No Sharing. Sharing, lending, renting, selling, or making any other unauthorized use or misuse of the original source software and/or backup copy constitutes a serious breach of this Agreement and will result in the immediate termination of this License and infringement of Latinotype's rights, causing significant economic damage, which will be prosecuted in any jurisdiction in which the license was acquired.

6. No Modification or Customization. You are not permitted to alter the Font Software in any manner whatsoever. You are not authorized to make, or hire others to make, custom or derivative versions of the original Font Software.

You are not permitted, by way of example not limitation, to decompile, reverse engineer, disassemble, modify, alter, or change the software or any associated embedding bits. You hereby acknowledge that the unauthorized modification or customization of Font Software shall be an infringement of Latinotype’s rights, causing significant monetary harm.

If you are interested in utilizing a customized Font, contact Latinotype for more information and fees.

7. Exclusive Ownership. Latinotype, its successors, and assigns hold all intellectual property rights, including full ownership and exclusive title, to their software, trademarks, copyrights, and the unique font designs contained within the Font Software. Licensing or using the Font Software does not transfer or diminish these rights.

You agree not to copy the Font Software or create derivative works based upon the Font Software and/or the design embodied in the Font Software.

You hereby agree that this term is contractual in nature and that the unauthorized use of the Font and/or the Font Software shall be an infringement of Latinotype's rights, causing irreparable harm and significant monetary damage which cannot be readily estimated.

You further agree that Latinotype shall be entitled, without the obligation of bond, to seek injunctive relief to prevent such harm.

8. Trademarks. All use of the trademarks associated with Font Software incur solely for the benefit of the trademark owner.

No ownership rights are granted under this License Agreement. Latinotype reserves all rights not expressly granted herein.

9. Transfer of License. You are permitted to transfer this License to use the Font Software one (1) time only and only to another end user. In any case you may assign

or transfer contractual rights or obligations under this Agreement in whole or in part to an Affiliate or, in the event of a disposal in whole or in part of the Licensee business or company to which the Font Software relate, to the purchaser of such business or company (in each case without further requirement of consent from Latinotype).

Under no circumstances are you permitted to purchase this License for resale purposes. Upon transfer of this License, you agree that (i) You will transfer the original Font Software together with all documentation, (ii) Any such transfer is not by consignment or other indirect means, (iii) The new licensee reads, understands and agrees with the terms of this License, and (iv) You will destroy all other copies on the Font Software and any documentation remaining in your possession. Upon transfer of the Font Software, you are not permitted to retain copies for yourself, lend or otherwise provide copies of the Font Software to commercial printers or service bureaus.

10. Warranties. Latinotype will, at both Parties discretion, either replace the Font Software or refund the Licensing fee in the event the Font Software does not perform substantially in accordance with the Documentation provided that any such claim is submitted within nine (9) months of purchase of this License. Latinotype Undertake all reasonable efforts to achieve that use of the Font Software will be uninterrupted or error free. Except as expressly set forth in this Agreement.

To submit a claim, you must return the Font Software to Latinotype or place of purchase together with a copy of your sales receipt and certify that no copies remain in your possession or control.

You expressly acknowledge and agree that the use of Font Software is at your sole risk. The Font Software and related documentation are provided "AS IS" and, except as noted herein, is without warranty of any kind.

LATINOTYPE HEREBY EXPRESSLY DISCLAIMS ALL WARRANTIES, EXPRESS AND IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

LATINOTYPE DOES NOT WARRANT THAT THE OPERATION OF THE FONT SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT THE FONT SOFTWARE IS WITHOUT DEFECTS. THE FONT SOFTWARE IS NOT FAULT-TOLERANT AND IS NOT INTENDED AND WAS NOT DESIGNED OR MANUFACTURED FOR USE IN MANUFACTURING, NAVIGATION, AND CONTROL EQUIPMENT OR IN ANY OTHER CIRCUMSTANCES WHERE THE USE OR FAILURE OF THE FONT SOFTWARE COULD LEAD TO DEATH, PERSONAL INJURY, PROPERTY DAMAGE, PHYSICAL OR ENVIRONMENTAL DAMAGE. UNDER NO CIRCUMSTANCES SHALL LATINOTYPE BE LIABLE TO YOU OR ANY OTHER PARTY, WHETHER IN CONTRACT OR TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, FOR ANY SPECIAL, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING LOST PROFITS, SAVINGS OR BUSINESS INTERRUPTION AS A RESULT OF THE USE OF THE FONT SOFTWARE EVEN IF NOTIFIED IN ADVANCE OF SUCH POSSIBILITY.

Latinotype's liability to you shall in no event exceed the cost of the Licensing fee or replacement of the Font Software, either at Latinotype's sole discretion. The foregoing limitations and/or exceptions to liability contained in this section shall not apply to claims, liabilities or expenses resulting from (a) Latinotype's material breach of this Agreement or (b) the gross negligence, intentional or willful misconduct, or any criminal conduct that requires scienter of Latinotype (collectively, the "Excluded Claims").

11. Guarantee of indemnity. All fonts, designs, software, documentation, font files, and any other related materials covered by this agreement or license are the exclusive property of Latinotype. Furthermore, Latinotype represents that the Purchaser's use of the Font in accordance with the agreed terms does not and will not infringe any third-party rights. Consequently, Latinotype will indemnify the Purchaser against any third-party claims arising from any infringement of intellectual property rights related to the Font, provided that the Purchaser's use is in accordance with this agreement.

12. Other Laws. Some jurisdictions do not allow the exclusion or limitation of incidental, consequential, or special damages, or implied warranties. ANY IMPLIED WARRANTY OR CONDITION CREATED BY LAW IS ONLY EFFECTIVE FOR THE NINE-MONTH (9-MONTH) WARRANTY PERIOD OR AS OTHERWISE REQUIRED UNDER APPLICABLE LAW. THERE ARE NO WARRANTIES OR CONDITIONS OF ANY KIND AFTER THE NINE-MONTH (9-MONTH) WARRANTY PERIOD. The exclusions noted above may

not apply to you. Otherwise, and to the extent permissible by law, you agree that all implied warranties are not effective for more than nine (9) months.

13. Termination. This License Agreement is effective as of the date of full payment for the License.

This License Agreement may be terminated by you at any time by destroying the Font Software together with any printed material and any copies of the Font Software. This License Agreement may be terminated without notice if you materially breach and/or fail to materially comply with any term contained herein, provided such breach or failure is uncurable or is otherwise not cured within five (5) business days following notification to you.

14. Governing Law. You expressly agree that this Agreement shall be governed, enforced, and construed in accordance with the laws of Chile as they apply to contracts entered and performed therein and without regard to its conflict of law provisions or the conflict of law provisions of any other jurisdiction.

You expressly agree that the courts of Santiago, Chile shall have exclusive jurisdiction for any action or proceeding arising out of or related to this Agreement and you hereby waive any defenses arising out of the choice of law or forum identified herein. You agree that any breach of this Agreement shall cause irreparable harm and that such damages cannot be estimated and that either party shall be entitled to seek equitable relief including, but not limited to, temporary restraining orders

and preliminary injunctions, each, without the obligation of a bond. Latinotype expressly reserves all rights.

15. Compliance with Law and Export Restrictions. With respect to the software licensed to you under this Agreement, you agree to be responsible for compliance with all laws, foreign and domestic, relating to the control of exports or the transfer of technology.

16. Severability. If any provision of this Agreement is declared by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions of this Agreement shall continue in full force and effect, and the invalid provision shall be replaced by the parties with a provision that most closely effects the intent of the invalid provision.

17. Entire Agreement. This Agreement constitutes the entire understanding between the parties and supersedes all previous agreements, promises, representations and negotiations between the parties. If any provision of this Agreement is held invalid or unenforceable for any reason, the remaining provisions will continue in full force and effect without being impaired or invalidated in any way. The failure of either party to enforce or delay in enforcing any provision of this Agreement will not be deemed a waiver of future enforcement of that or any other provision of this Agreement.

18. One Back-Up. You are permitted to make one (1) back-up copy of the Font Software for archival purposes only. Unauthorized sharing, lending, renting, sale, or

other unauthorized use or misuse of the original Font Software and/or the back-up copy is a material breach of this Agreement and will result in immediate termination of this License.

19. The Licensed Party's continued success is important to Latinotype, which is committed to fostering a long-standing relationship with the Licensed Party. Therefore, Latinotype desires that the Licensed Party be fully referenceable. Latinotype reserves the right to display a description and other information related to its Work Product in Latinotype's portfolios and websites, and in galleries, design periodicals, and other media or exhibits for the purpose of recognizing creative excellence or professional advancement, and to be credited with authorship of the Services and/or the Work Product in connection with such uses. Subject to an obligation of confidentiality, the Licensed Party grants Latinotype and its affiliates a limited, non-revocable right and license to use and publicly display information related to the Services and/or its Work Product, which may include the Licensed Party trademarks, names, logos, or domain names, on Latinotype's blog, website, social media channels, or in other marketing or advertising materials, solely in connection with the promotion and marketing of Latinotype's services.

20. Latinotype is an independent contractor, not an employee of the Licensed Party or any company affiliated with the Licensed Party. This Agreement does not create a partnership or joint venture, and neither party is authorized to act as an agent or bind the other party except as expressly provided in this Agreement. All rights, if any, granted to the Licensed Party are contractual in nature and are fully defined by

the express written agreement of the parties and the various terms and conditions of this Agreement.

21. Personal Data Protection Clause. The Parties acknowledge that, by acquiring and using the font software, the Licensed Party is solely and exclusively responsible for the processing of any personal data that may be collected, processed, or stored through the use of the font software. Latinotype does not access, process, or have control over such data, and the font software acts as a technological tool for the Licensed Party.

Latinotype declares that the font software is not designed to process personal data, but it does not have access to, control, or process any personal data that the Licensed Party may collect, process, or store through the use of the font software. Therefore, Latinotype shall not be liable for any violation of the Law or data protection regulations committed by the Licensed Party in its use of the font software.

The Licensed Party shall hold Latinotype harmless from any claim, demand, fine, penalty, or legal action arising from its failure to comply with the obligations established in this agreement for any violation of personal data protection regulations in its use of the font software.

22. Confidential Information. During Latinotype's relationship with the Licensed Party, each Latinotype and the Licensed Party (each, the "Receiving Party") may have access to non-public, oral or written information relating to the business operations

or prospects of the other (the "Disclosing Party"), or that of its parent, subsidiaries or affiliates ("Confidential Information"). Confidential Information includes, without limitation: trade secrets and other confidential data and/or proprietary information, present and future business plans, information memoranda, reports, the identity of the Disclosing Party's clients, research, investigations, works in progress, marketing and sales information, financial projections, financial information, projections, confidential filings with national and international agencies, and all other confidential concepts, methods of doing business, ideas, materials or information.

23. Headings. The captions of the sections of this License Agreement are for convenience only and shall not control or affect the meaning or construction of any of the terms or provisions of this Agreement.
